The amended label and CSF(s) referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, are acceptable. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

"To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.
