DIRECTIONS

HOLD CAN UPRIGHT WHILE SPRAYING

Hold nozzle 8-12 inches from area specified and thoroughly spray until wet, where insects rest, run or hide. Repeat all applications as necessary to maintain effective control.

ROACHES, WATERBUGS, CRICKETS, SILVERFISH: Treat around baseboards, cracks, under counters, drainboards, cabinets, sinks, drains, pipes, behind shelving, bookcases, moist areas; floors of closets, other storage areas and where they crawl as they come out of hiding.

ANTS: Thoroughly treat ant trails, refuse containers, door sills and window frames, openings around baseboards, pipes, ducts, other ports of entry and areas frequented by ants.

SPIDERS, SCORPIONS, CENTIPEDES: Spray until wet, infested baseboards, corners, door and window casings and sills, storage localities and surfaces over which they crawl. Spray insects directly when possible.

CAUTION

"HARMFUL IF SWALLOWED"

COMBUSTIBLE MIXTURE—Do not spray into or near open flame. Do not smoke while spraying. Contents are under pressure—exposure to high temperatures could cause bursting. Keep at room temperature away from direct sunlight, radiators, stoves, hot water and other sources of heat above 120 F. Do not puncture container or incinerate.

Spray surfaces only—do not spray into air or contaminate feed, foodstuffs, cooking utensils, animals or humans. Contact with skin may cause toxic symptoms. Avoid breathing spray mist. In case of skin contact, wash with soap and water. If taken internally, give emetic of mustard and call physician.

"Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed."
