### FOR CONTROL OF FLYING INSECTS . . . SPRAY AS FINE MIST OR FOG INTO AIR.

**To Kill Flies, Mosquitoes, Fruit Flies and Wasps:** Direct fine mist of Insekon 100 toward upper portions of closed draft-free areas. Use 1 fluid ounce of Insekon 100 for each 1000 cubic feet of air space or fill room with mist. Keep room closed for 15 minutes for maximum effectiveness. Do not remain in treated areas. Ventilate the area after treatment is completed.

**To Kill Stored Pests:** To control the exposed stages of granary weevil, rice weevil, confused flour beetle, rust red flour beetle, sawtooth grain beetle, angoumois grain moth, mediterranean flour moth and drugstore beetle in restaurant and institutional food storage areas, destroy or remove infested products to avoid reinfestation. Clean all food storage areas then spray all surfaces, cracks, and crevices with Insekon 100. After initial cleanup, routine applications of Insekon 100 at monthly intervals or as necessary will deter reinfestation.

### FOR CONTROL OF CRAWLING INSECTS . . . APPLY AS COARSE SPRAY TO INFESTED AREAS.

**To Kill Roaches, Ants, Spiders and Waterbugs:** Thoroughly spray all insect hiding places and trails, under, behind and around equipment and fixtures, including cracks, dark corners, under drainboards, counters, cabinets, tables, shelves, pipes, in and around moist areas, refuse containers, and where they crawl as they come out of hiding or enter rooms. Repeat treatments as necessary to maintain effective control.
