

**Dosage:**

This 3 Oz. medication made expressly for animals of 300 to 400 lbs. body weight.

**Directions:**

Reduce amount of feed at evening to a very minimum then the following morning mix the entire contents of this package with the normal amount of feed. Allow horse to consume all of medicated feed before additional feed is given. Remove and destroy any medicated feed not consumed within 12 hours after being offered.

**Caution:** Do not treat pregnant mares within thirty days prior to foaling. Do not treat horses weighing less than 300 lbs. with this formulation. Do not use on horses intended for use as food. Do not exceed the recommended dosage. Do not retreat horses at intervals of less than 30 days.

**Notice:** Do not treat sick or emaciated horses except on the advice of a veterinarian. Should symptoms of overdosing such as muscular incoordination, colic, or abdominal pain appear, consult your veterinarian. Should this material cause cholinesterase inhibition Atropine is antidotal. Give 100 mg. or 1 1/2 grains per 1000 lbs. body weight.
