DIRECTIONS

For Horse Barns: To control flies use a finished spray containing 0.3° Lindane (1 gallon of TPC 10% Lindane in 33½ gallons of water). Apply spray at the rate of 1 gallon finished spray for each 500 square feet area of walls, ceilings, beams, window sills, and other places where insects may alight or crawl. Coarse sprays are desirable; power prayers with agitation and less than 100 pound pressure are recommended. Spray should be applied so as to wet all treated surfaces to the point of run off. Feed, forage, and drinking troughs should not be sprayed. Drinking troughs should be washed out immediately if sprayed accidentally.

For Scab or Sarcoptic mange mites on beef cattle, hogs, sheep, and goats use a finished spray containing 0.046% Lindane. (1 gallon TPC 10% Lindane concentrate in 2171/2 gallons of water).

Use a sprayer giving about 400 pounds pressure and thoroughly spray each animal all over using 1 or more quarts of spray or the amount needed to ensure that animal's skin is thoroughly wet. Repeat application at 7-day intervals for one or more treatments.

Caution: Do not dip beef cattle, sheep, goats or hogs within 60 days of slaughter. Do not spray within 30 days of slaughter.

Do not treat sows within two weeks of farrowing nor for at least three weeks thereafter.

Avoid treating animals in cold, stormy weather. Avoid treating overheated or sick animals. Do not use on emaciated animals or dairy animals.

For Ticks and Lice: To control ticks and lice on beef cattle sheep, goats and hogs use as directed for Sarcoptic mange. Use a finished spray containing 0.046% Lindane (1 gallon TPC 10% Lindane in 2171/2 gallons of water). Apply as directed for Sarcoptic mange. Repeat in 14 days only if needed for control.

Note: This product should not be used above the recommended percentage levels. Beef cattle should not be dipped in order to minimize the likelihood of possible residue problems which could result from this use.
