

HORSE INSECTICIDE

DIRECTIONS:

TPC HORSE INSECTICIDE is made especially for use on horses. It gives a protective hair coating against flies. 1-2 ounces per animal applied daily with a soft cloth or as a fine mist spray usually provides adequate protection.

Make sure horse's hair coat is free of dirt by brushing thoroughly before making application. Moisten a soft cloth with TPC HORSE INSECTICIDE and rub over the hair paying special attention to the legs, shanks, shoulders, neck and areas around the face where flies generally are seen. Rub against hair growth and apply lightly. Avoid using an excessive amount on animals. Do not wet skin. Brushing thoroughly after application will help bring out a sheen on hair coat. Repeat application daily or as needed.
