

TO OPERATE—PRESS BUTTON TO RELEASE SPRAY

DIRECTIONS

Hold nozzle from 3 to 6 inches away from surface to be treated and spray across the surface about 1 or 2 feet per second so as to leave a wet surface. Repeat as often as necessary.

Spray cracks, crevices, baseboards and damp areas and other hiding places. Spray areas around frames, doors and any other place where ants enter premises. Spray ant trails. Be sure and spray crawling insects and surfaces only.
