

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS (AND DOMESTIC ANIMALS)

CAUTION

Harmful if swallowed. Avoid contact with eyes, skin or clothing. Avoid contamination of feed and food stuffs. Remove pets, birds, and cover fish aquariums before spraying. Do not use on edible crops. Do not remain in treated areas. Ventilate the area when treatment is complete.

FIRST AID

In case of contact, immediately flush eyes and skin with plenty of water for at least 15 minutes. Get medical attention if irritation persists. If swallowed, do not induce vomiting. Call a physician at once.

ENVIRONMENTAL HAZARDS

Keep out of lakes, streams, or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment, or disposal of wastes.

DIRECTIONS FOR USE

(Continued from Left Panel)

INDOORS: TO KILL HOUSEFLIES, MOSQUITOES, AND GNATS:

Apply as a space spray. Mix well before using. Fill spray tank with undiluted insecticide. Adjust pressure and nozzle to deliver a fine mist spray. Close all doors and windows. Point nozzle upward, direct the spray mist to all parts of the room, especially windows and other light sources which attract these insects. Keep the spray nozzle at all times at least four feet from fabrics to avoid wetting or staining. Fill the room with mist at the dosage of one fluid ounce per 1,000 cu. ft. of space. Then leave the treated area. Keep the room closed for at least 15 minutes. Ventilate the room when treatment is completed and before re-entry.

INDOORS-TO KILL CRAWLING INSECTS: Apply as a contact spray. Mix well before using. Fill spray tank with undiluted insecticide. Keep spray nozzle about 8 to 12 inches from surface to be treated. Adjust pressure and nozzle to deliver a coarse spray with particle size larger than that of the average aerosol. When possible, spray directly on centipedes to reduce infestations. Spray thoroughly in to hiding places such as cracks, crevices, moist areas, open gaps around pipes and sinks, under refrigerators, baseboards, and storage areas. Apply spray until area is moist, but not to the point of run-off. Spray directly on insects where possible. Repeat as necessary.

TO KILL ANTS INDOORS OR TO CONTROL ANTS OUTDOORS: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

TO KILL ANTS INDOORS OR TO CONTROL ANTS OUTDOORS: Protect dogs and cats from fleas by spraying their resting areas. Hold spray nozzle about 10 inches from area to be treated. Apply spray at the rate of two seconds per linear foot. Direct spray on resting areas and floor around these areas. Treat bedding the same way. Also spray entire inside surface of dog houses. Repeat as necessary.

Also treat dogs and cats with a registered product before they enter the area just treated with this product.

OUTDOORS-TO CONTROL NUISANCE PESTS: Apply as a coarse contact spray. Spray directly on insects.

OUTDOORS-TO KILL SPIDERS: Direct short bursts of spray on spiders and repeat as necessary.

OUTDOORS-TO KILL WASPS: Application should be made in late evening when insects are at rest. Spray liberally in flying and breeding places contact as many insects as possible. Repeat as necessary.
