On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.

2. Make the following label changes:

- a. Revise the EPA Registration Number to read, "EPA Reg. No. 334-570".
- b. The claim "Keeps on killing for up to 4 weeks" is not on your reference product's labeling. Therefore you must delete this claim wherever it appears on the labeling.
- c. Your product is classified according to acute toxicity as a Category III (Caution signal word) for the inhalation route only. All other acute toxicity categories are classified as Category IV. You may delete all other categories under Statement of Practical Treatment except IF INHALED which should be revised as follows: "IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth to mouth. Get medical attention."

- d. The precautionary statements should also be revised (see comment 3 above) as follows: "Harmful if inhaled. Avoid breathing vapor or spray mist....."
- e. Under **NOTE** for Fleas, Ticks and Lice on Dogs add the following: "Do not use on old, sick or debilitated animals. Do not use on cats."
- f. Revise the front panel site of application to read as follows:

"For Household (Residential) Use Only"

If it is your intent to market this product in commercial establishments then additional directions and precautions will be required.

3. The upper and lower certified limits for the following components should be reversed under columns 14a and 14b: Pyrethrins, Permethrin, Piperonyl Butoxide (technical), inerts from concentrate, odorless mineral spirits and water.

4. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

Water based formula provides broad spectrum dual killing action without oily residues and staining. Use on floors and carpets without staining. Contains synergized fast killing knockdown active ingredient to kill on contact and a residual action active ingredient for continued killing on treated surfaces for up to 4 weeks after spraying.

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

FOR HOUSEHOLD USE: SHAKE CONTAINER WELL BEFORE EACH USE. Apply to surfaces only, not up into the air. Spray directly on insects whenever possible. Point spray opening toward target and press button firmly. Hold 12 - 15 inches from target being sprayed. Spray until surfaces are wet. Repeat treatment as necessary.

ROACHES, WATERBUGS, SILVERFISH, CRICKETS, SCORPIONS, SPIDERS, MILLIPEDES, CENTIPEDES, SOWBUGS: Spray until wet into hiding places such as cracks around baseboards and crevices and other hiding places. When bugs are driven out, spray directly whenever possible.

ANTS: Apply to ant trails, also around doors, windows and wherever ants enter house.

BEDBUGS: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat baseboards, moldings and floors. Repeat treatment as necessary. Allow all sprayed articles to dry thoroughly before use.

FLEAS & TICKS (ADULTS and LARVAE): Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters, bed, entire floor and floor covering, with special attention to cracks and crevices around baseboards, and window and door frames. Treat infested upholstered furniture and mattresses. Make a test application to upholstery or drapery fabrics in an inconspicuous place before use.

FLEAS, TICKS and LICE ON DOGS: Starting at the head, stroke against the lay of the hair, spraying the parted fur in short bursts, directly behind the hand to insure penetrating the coat. Dampen the fur back to tail. Repeat application weekly if necessary to control infestations. **NOTE:** Not recommended for use on puppies less than four weeks old.

LICE and LOUSE EGGS: Use only on those garments and parts of bedding, including mattresses and furniture, that cannot be either laundered or dry cleaned. First spray in an inconspicuous area to test for possible staining or discoloration. Inspect again after drying, then proceed to spray entire area to be treated. Spray from a distance of 8-10 inches. Spray each square foot for three seconds. Allow all sprayed articles to dry thoroughly before use.

STORAGE AND DISPOSAL:

STORAGE: Store in a cool, dry area, inaccessible to children and away from heat or open flames. Do not transport or store below 32° F. **DISPOSAL:** This container may be recycled in the few but growing number of communities where (steel) aerosol can recycling is available. Before offering for recycling, empty the can by using the product according to the label. (DO NOT PUNCTURE!) If recycling is not available, wrap the container and discard in the trash.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS:

CAUTION: Harmful if swallowed, absorbed through the skin or inhaled. Avoid breathing vapor or spray mist. Avoid contact with skin or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Provide adequate ventilation of area being treated. Do not apply to humans or contaminate feed, foodstuffs, dishes or utensils. Cover and avoid spraying fish aquariums. Cover or remove exposed food, dishes, utensils and food handling equipment. Do not allow children or pets to contact treated areas until surfaces are dry.

STATEMENT OF PRACTICAL TREATMENT:
