It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

HOW TO USE: SHAKE BEFORE USING. Spray infested surfaces until wet.

To Control Ants, Boxelder Bugs, Centipedes, Cockroaches, Crickets, Earwigs, Pillbugs, Scorpions, Silverfish, Spiders, Cigarette Beetles and Waterbugs: Spray areas where these pests are found or may hide including dark corners of rooms, closets, cracks, crevices, along baseboards, door sills and frames, beneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installations. Pests flushed out of hiding should be sprayed directly.

Ants: Treat ant trails, nests and points of entry. Repeat treatment as necessary.

To Control Brown Dog Ticks: Thoroughly spray sleeping quarters of animals. Spray infested areas around baseboards, windows and door frames, wall and floor coverings where localized areas of infestation occur. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. **Do Not Treat Animals With This Formulation.**

To Control Carpet Beetles and Clothes Moths: Spray edges of carpeting and under carpeting, rugs and closets. Make localized application to the floor and baseboards. Spray directly into cracks, crevices, closets and infested areas of shelving and/or wherever these insects are seen or suspected. Repeat as necessary.

To Control Gnats, House Flies, Mosquitoes and Small Flying Moths: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures or porches in garages and other places where these insects alight or congregate.

To Control Fleas Indoors: Thoroughly apply as a spray for spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area. **Do Not Treat Pets With This Product.** To control the source of the flea infestation, pets inhabiting the premises should be treated with a product registered for application to animals.
