Du Pont Karmex® Weed Killer is recommended for use as a tank mix with Zorial® 80 TP* for preemergence control of annual weeds as shown on Karmex® labeling plus control of prickly sida (teaweed), anoda, spurge, and goosegrass in Arkansas, Louisiana, Mississippi, the bootheel of Missouri and West Tennessee.

HOW TO USE

Apply preemergence after planting and before cotton seedling emerge as follows:

Sandy loam	0.5-1.0 plus 0.6
Loam, Silt loam, Silt	0.5-1.0 plus 0.9
Sandy clay loam	1.25 plus 0.9
Clay loam, Silty clay loam, Sandy clay	1.25 plus 1.25
Silty clay, Clay	2.0 plus 1.25

Broadcast; for band treatment apply proportionate

Shallow incorporation (no deeper than 1/4") with a rotary hoe or similar equipment following planting usually improves results especially during dry weather. A wide press wheel should be used on the planter to provide a level seedbed for subsequent early season postemergence treatments. If moisture is insufficient to activate Karmex® plus Zorial® or if soil becomes crusted before crop emerges, a shallow rotary hoeing (no deeper than 1/4") should be made before weeds become established.




