Apply preemergence after planting and before cotton seedling emerge as follows:

Do not treat cotton in deep furrows as crop injury may result; use only where cotton is planted on flat or raised seedbeds. Shallow incorporation (no deeper than 1/4") with a rotary hoe or similar equipment following planting usually improves results especially during dry weather. A wide press wheel should be used on the planter to provide a level seedbed for subsequent early season postemergence treatments. If moisture is insufficient to activate Karmex® plus Zorial® or if soil becomes crusted before crop emerges, a shallow rotary hoeing (no deeper than 1/4") should be made before weeds become established.

<u>Replanting</u>: If initial seeding fails to produce a good stand, cotton may be replanted in soil treated precergence with Karmex<sup>®</sup> plus Zorial<sup>®</sup>. Wherever possible, avoid disturbing original bed. If necessary to rework soil before replanting, use shallow cultivation such as discing; do not relist nor move soil into the original drill area. Plant seed at least 1" deep. Do not retreat field with a second preplant or preemergence application during the same crop year as injury to the crop may result.

<u>NOTE</u>: Injury to cotton may occur if Karmex<sup>®</sup> plus Zorial<sup>®</sup> is used in conjunction with organophosphate pesticides.

Cover crops planted after harvest should be plowed under and not grazed or harvested. To minimize injury to small grain cover crops, they should be broadcast planted rather than drilled.

Treated acreage may be replanted only to cotton. The next Spring, treated acreage may be rotated to soyberns. One year after application of the Karmex<sup>®</sup> plus Zorial<sup>®</sup>, treated acreage may be rotated to peanuts.

Do not allow livestock to graze treated cotton.
