

LEXONE® 4L WEED KILLER AND COMBINATIONS WITH KARMEX® FOR USE ON ESTABLISHED ASPARAGUS IN THE NORTHWEST

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Du Pont Lexone® 4L Weed Killer is recommended alone or in combination with Karmex® Weed Killer for use on established asparagus in the Northwest. For weeds controlled, refer to package labels for "Lexone" 4L and "Karmex".

HOW TO USE

Use of the following:

"Lexone" 4L Preemergence Treatment Only: Make a single preemergence application of 2 to 4 pts. "Lexone" 4L per acre in early spring prior to spear emergence. Use the lower rate on coarse textured soils (low in clay or organic matter). If field is to be disked, apply "Lexone" 4L after disking but before crop emerges.

OR

"Lexone" 4L Preemergence and Post-Harvest Treatment: Make a single preemergence application of 1 to 2 pts. "Lexone" 4L per acre in early spring prior to spear emergence. Following harvest but before fern emerges, apply 1 to 3 pts. "Lexone" 4L per acre. Do not exceed 4 pts. "Lexone" 4L per acre per growing season.

"Lexone" 4L Preemergence and "Lexone" 4L Plus 'Karmex' Post Harvest Treatment: Make a single preemergence application of 1 to 2 pts. "Lexone" 4L per acre in early spring prior to spear emergence. Following harvest but before fern emerges, apply a tank-mix combination of 1 to 1 1/2 pts. "Lexone" 4L plus 1 to 2 lbs. "Karmex" per acre.

Irrigated Asparagus: After the initial application of 'lexone' 4L, do not exceed more than 1/2" of water for the first irrigation. Additional irrigations may be normal programs.

Application: Apply in 3-10 gallons per acre by air or 10-40 gallons per acre by ground equipment.

NOTE:

Do not use on newly seeded nor on young plants during the first growing season after setting crowns. Do not apply within 14 days of harvest. If field is to be disked, apply "Lexone" 4L after disking but before the crop emerges. Do not apply post—harvest application until after the last harvest of spears.

Use of the following:

"Lexone" $\overline{\text{DF}}^{\text{IM}}$ Preemergence Treatment Only: Make a single preemergence application of 1 1/3 to 2 2/3 lbs. "Lexone" $\overline{\text{DF}}^{\text{IM}}$ per acre in early spring prior to spear emergence. Use the lower rate on coarse textured soils (low in clay or organic matter). If field is to be disked, apply "Lexone" $\overline{\text{DF}}^{\text{IM}}$ after disking but before crop emerges.

OR

"Lexone" DFTM Preemergence and Post-Harvest Treatment: Make a single preemergence application of 2/3 to 1 1/3 lbs. "Lexone" DFTM per acre in early spring prior to spear emergence. Following harvest but before fern emerges, apply 2/3 to 2 lbs. "Lexone" DFTM per acre. Do not exceed 2 2/3 lbs. "Lexone" DFTM per acre per growing season.

OR

"Lexone" DFTM Preemergence and "Lexone" DFTM Plus "Karmex" Post Harvest Treatment: Make a single preemergence application of 2/3 to 1 1/3 lbs. "Lexone" DFTM per acre in early spring prior to spear emergence. Following harvest but before fern emerges, apply a tank-mix combination of 2/3 to 1 lb. "Lexone" DFTM plus 1 to 2 lbs. "Karmex" per acre.

Irrigated Asparagus: After the initial application of "Lexone" DFTM, do not exceed more than 1/2" of water for the first irrigation. Additional irrigations may be normal programs.
