



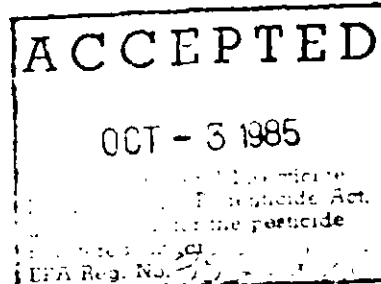

DIRECTIONS FOR USE

It is a violation of federal law to use these products
in a manner inconsistent with the labeling

Du Pont Lorox® Herbicide plus atrazine plus "Lasso" EC is recommended as a tank mixture for control of many annual weeds in field corn. Refer to package labels of each product for specific weeds controlled and special use instructions.

HOW TO APPLY

Make a single application of the tank mix after planting, but before crop emerges; use 20 to 60 gallons of water per acre. Plant seed at least 1 3/4 inches deep on flat or raised seedbeds only or injury to the crop may result. Do not spray over top of emerged corn.

Apply at the following broadcast rates per acre; for band treatment use proportionately less. For example, for 14" band on 42" row, use 1/3 of the broadcast rate.

* For improved control of annual grasses, add "Lasso" EC as recommended on "Lasso" EC labeling for "Lasso" EC/atrazine combinations.

** For atrazine liquid 4 lbs/gal, 1 pint = 3/5 lb of 80% wettable powder.

Do not use this mixture on coarse soil (loamy sand, sand) nor on soils with less than 1% organic matter as crop injury may occur. Do not use on soils with more than 5% organic matter as poor weed control will result.

If initial seeding fails to produce a stand, treated fields may be replanted to corn. Do not retreat field with a second application as injury to the crop may result. After 6 months, any crop may be planted except do not follow treated corn with sugar beets, tobacco, or vegetables in rotation.
