Du Pont "Lannate" Insecticide is recommended for use on mint to control mint flea beetles.

HOW TO USE

Apply 3/4 to 1 lb. "Lannate" per acre in sufficient water to give uniform coverage (10 to 20 gallons of water per acre) by air or ground equipment. Begin applications when insects first appear and repeat at 5- to 7-day intervals or as needed.

Note: Do not apply within 14 days of harvest. Do not apply when bees are actively foraging mint fields in bloom.
