STORAGE AND DISPOSAL

Storage: Never allow Benomyl Technical to become wet during storage. This may lead to certain chemical changes which will reduce the effectiveness of Benomyl Technical as a fungicide. Keep container tightly closed when not in use. Store product in original container only. Do not contaminate water, other pesticides, fertilizer, food or feed in storage.

Product Disposal: Do not contaminate water, food or feed by disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into manufacturing equipment. Then dispose of liner in a sanitary landfill or by incineration if allowed by State and local authorities. If drum is contaminated and cannot be reused, dispose of in the same manner.

DIRECTIONS FOR USE

Terrestrial Food Crops - Almonds, apple, avocados (FL only), beans (dry, lima, snap), blueberries, brussel sprouts, chinese cabbage, turnip greens (AL, AZ, FL, GA, KY, LA, MS, NC, SC, TN, VA only), caneberries (raspberries, blackberries, boysenberries, loganberries, dewberries), carrots, celery, citrus, cucurbits (cucumber, melons, pumpkin, squash), currants, dandelions (FL only), grapes, macadamia nuts (HI only), mangoes, mushrooms, papaya, peanuts, pears, pecans, pistachios (CA only), soybeans, stone fruit (apricots, cherries, nectarines, peaches, plums/prunes), strawberries, sugarbeets, tomatoes, wheat, yams (PR only).

Terrestrial Non-Food Crops: Seed treatment (Barley, broccoli, brussel sprouts, cabbage, chickpeas, (ID and WA only), chinese cabbage, cauliflower, collard, kale, kohlrabi, mustard greens, oats, rape, rutabagas, rye, spinach, turnips, and wheat).

Seed piece treatment garlic (CA only), pineapple.

Seed crop treatment (Anise, brussel sprouts, cabbage, cardoon, cauliflower, chickory, corn, cucumbers, dill, melons, onions, (CA only), peas, bell peppers, squash).

Aquatic Food Crops: Rice (Not in California).

Miscellaneous Uses: Caprifigs (CA only).
