> e You submit 5 copies of the final printed labeling for the supplemental labeling before releasing the product for snipment.

If this condition is not complied with, the registration will be subject to cancellation in accordance with FIFRA, Section 6(e). Your release for shipment of the product constitutes acceptance of this condition. Stamped copies of these label are enclosed for your records.

Your request to cancel "Pin: Plantations" and "Conifer Plantations as use sites for this product must be processed in accordance with PR Notice 91-1, before these use-patterns can be cancelled. We have initiated the preparation of a Pederal Register Notice of your request.

GENERAL INFORMATION

Du Pont "Krenite" S Brush Control Agent is a water soluble liquid to be diluted with water and applied as a foliar spray for control and/or growth suppression of many woody species. A spray directed to only part of susceptible brush species will provide control of the portion sprayed, resulting in a trimming effect. It is applied to brush during the period from full leaf in spring to first fall coloration. "Krenite" S treatment does not immediately affect treated woody plants; they remain green for the rest of the growing season. Treated susceptible plants fail to grow the next spring.

It is recommended for use on noncropland, including highway rights-of-way, industrial sites, railroad rights-of-way strage areas, utility and pipeline rights-of-way, campgrounds, and ditch banks. "Krenite" S is non-flammable and non-volatile.

Do not apply to open water (such as lakes, reservoirs, rivers, streams, creeks, salt water bays or estuaries) nor while water in present in fresh water wetlands (such as marshes, swamps, bogs or potholes) nor to salt water marshes within tidal areas nor to areas where the herbiside is likely to move into water. It is permissible to treat ditch banks, seasonally dry flood plains, deltas, marshes, swamps, bogs and transitional areas between upland and towland sites.

SPRAY PREPARATION

Measure the proper amount of "Krenite" S and use agitation to thoroughly mix into the necessary volume of water. To enhance the activity of the "Krenite" S treatment, the addition of 1/4% (by volume) of a non-phytotoxic superior-type (60-70 second viscosity) oil as the last "gredient may be desirable in some areas. (Consult local sales personner). After "Krenite" S has been thoroughly mixed in the spray tank, agitation of the spray solution is not required.

SPRAY APPLICATION METHODS

Before applying, properly calibrate spray equipment. For woody plant control, make a single foliar application of the recommended rate of "Krenite" S during the period from full leaf in spring to first fall coloration. For control of only a portion of a plant, as in trimming, direct the spray to thoroughly cover only the section of the plant to be controlled. Use the highest recommended rate on stands in which species partially controlled and suppressed are dominant.

For high volume treatment (ground equipment) prepare a spray solution using 1 1/2 to 3 gallons "Krenite" S per 100 gallons of water. Do not prepare less than a 1 1/2% solution or exceed 6 gals. "Krenite" S per acre. Apply a quantity of spray solution which will thoroughly and uniformly cover the target brush without causing unnecessary run-off. Spray pressure at nozzles should be 100 to 300 psi. Total rate and volume per acre will depend on plant species, height and density of growth and on type of equipment used. On tall dense brush, it is often necessary to spray from both sides to obtain adequate coverage.

For low volume treatment (ground equipment) use airblast equipment such as a "Solo backpack mist blower", prepare a spray solution using 1-1/2 to 3 gallons "Krenite" S per 10 gallons of water. Apply a quantity of spray solution using equipment which will assure particle breakup and uniform coverage of the low spray volumes applied, without causing unnecessary run-off. Total rate and volume per acre will depend on plant species, height and density of growth, and on type of equipment used.

For aerial treatment, apply 1 1/2 to 3 gals of "Krenite" S per acre using 10 to 40 gallons of water to thoroughly and uniformly cover the target brush without causing unnecessary run-off. Total rate and volume per acre will depend on plant species, height and density of growth, and on type of equipment used. If foaming is encountered, use an anti-foam agent.

Note: Effectiveness may be reduced if, following treatment, rainfall occurs on the same day. Do not cut treated brush until stems are dead, or sprouting may occur.


