## VELPAR® GRIDBALL® 1CC BRUSH KILLER FOR CONTROL OF UNDESIRABLE WOODY PLANTS IN RANGELAND

Du Pont Velpar® Gridball® 1cc Brush Killer is recommended for use on rangeland for control of undesirable woody plants such as elm, hackberry, mesquite, myrtle, oaks (blackjack, post, sand shinnery, water, and white), osage orange, red cedar, tallow, whitebrush and willow. It is a special pelletized product to be distributed in a random grid pattern or on an individual stem basis. Rainfall dissolves the pellets and moves the herbicide into the root zone of the woody plants where it is absorbed during periods of active plant growth. The effect of treatment will vary with the amount applied, soil type, rainfall, timing and uniformity of application, and other conditions.

### DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Apply just before or during the period of active plant growth of brush species to be controlled (late winter to mid-spring), using the appropriate rates. Distribute by hand in a random grid pattern, as an individual stem treatment, or apply with appropriate aerial equipment. Calibrate equipment to insure uniform distribution of the pellets on area to be treated. Wear gloves when handling pellets to prevent contact with skin.

<u>Soil Texture</u>	<u>Lbs. Product Per Acre</u>
Sand, loamy sand, sandy loam	5
Silt loam, loam, clay loam	10

For hand application, the rate per acre is determined by the spacing between pellets in each direction on the soil surface - for 5 lbs. per acre, space pellets 6 ft. apart; for 10 lbs. per acre, 4 1/4 ft. apart.

For control of individual trees, use 2 to 3 pellets per inch of stem diameter at breast height. Apply near the root collar of the trees to be controlled.

Note: In areas of high rainfall, small stemmed brush (less than 2" in diameter) will only be controlled by individual stem treatment. Do not use on marshy or poorly drained sites, nor on soils classified as clays. Do not cut hay from treated grasses.
