The proposed amendments to the labeling of DuPont® Hexazinone Technical have been reviewed and found to be acceptable amendments to subject registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, provided that you:

- 1. Revise the listing of the use-site claims under the "Directions For Use" section to reflect the use-sites as listed on page 2 and 3 of the EPA Reregistration Eligibility Decision (RED) Hexazinone, dated September 1994. As presently stated the use in pasture and rangeland is listed as non-food/feed use sites.
- 2. Submit one (1) copy of the final printed label prior to your shipment of DuPont® Hexazinone Technical under the revised label.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, section 6(e). Your release for shipment under this labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.
