DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

DuPont "Bladex" 90DF Herbicide may be applied in a tank mix combination with "Banvel" or "Marksman" herbicides for the control of certain emerged grass and broadleaf weeds growing in corn.

WHEN TO APPLY

Apply from crop emergence through the four-leaf stage of corn growth but before weeds exceed about 1.5 inches in height. Do not apply over the top of corn if the fifth leaf is visible. Apply in water only. Do not spray emerged corn plants with "Bladex" 90DF in a liquid fertilizer carrier.

HOW TO USE

Apply as directed under "POSTEMERGENCE - BLADEX Applied Alone" section of the federal label. Add 1/2 p/A of "Banvel" or 1 q/A of "Marksman" to the spray mixture. Under dry conditions (low humidity and the absence of dew formation at night) and before the corn is in the 3-leaf stage, a nonionic surfactant may be added at a rate of 1 p/100 gal. of spray mixture to improve control of grass and broadleaf weeds. Do not use emulsible vegetable oil or petroleum based crop oils.

Addition of "Banvel" or "Marksman" will improve control of difficult broadleaf weeds, including triazine resistant biotypes.

Refer to "Marksman" label for atrazine rate limits and precautions on rotational crops.

APPLICATION INFORMATION

Refer to the respective labels for application information on application methods, gallonage, nozzles, pressures, and equipment. The most restrictive labeling shall apply.

All federal label guidelines for protective clothing, precautions and use requirements for "Bladex" 90DF must be followed.
