- 2. Apply this product to the entire tile-outletted terraced field and immediately incorporate it to a depth of 2-3 inches in the entire tile-outletted terraced field.
- 3. Apply this product to the entire tile-outletted terraced field under a notill practice only when high crop residue management practices are used. High crop residue management practice is described as a crop management practice where little or no crop residue is removed from the field during or after crop harvest.
