Limited use will occur in Alamosa, Conejos, Costilla, Rio Grande, and Saguache counties with selected cooperators and retail dealers. Consult the "Conditions of Use" section below and the EPA approved EXPRESS® and HARMONY® EXTRA labels for additional requirements, restrictions and precautions.

#### CONDITIONS FOR USE

EXPRESS® and HARMONY® EXTRA may be applied to wheat and barley by those selected cooperators and retail dealers who have a current year letter of consent from DuPont in this geography.

#### **HOW TO USE**

EXPRESS® and HARMONY® EXTRA can be applied by ground or air equipment under this labeling. See EPA approved label for specific ipment recommendations.

Use 1/4 to 1/3 ounce per acre of EXPRESS® or 0.3 to 0.6 ounce per acre of HARMONY® EXTRA in the above counties. Tank mixtures should be used, refer to the EPA approved label for further instructions about tank mixing.

Read and follow all the label instructions and precautions for the other products used in a tank mix with EXPRESS® and HARMONY® EXTRA.

#### SPRAY DRIFT MANAGEMENT

The interaction of many equipment and weather-related factors determines the potential for spray drift. The applicator is responsible for considering all these factors when making application decisions.

#### SPRAYER CLEANUP
