- 2. Terrestrial Feed Crops or Non-Food Uses: Fallow, grass and sorghum.
- 3. Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration.
- 4. Uses for experimental purposes that are in compliance with USEPA requirements.

STORAGE AND DISPOSAL

Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then, (a) for Plastic Containers, offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning; if burned, stay out of smoke, or (b) for Metal Containers, offer for recycling if available or reconditioning if appropriate or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Nonrefillable Plastic and Metal Container. apacity Greater Than 50 Pounds): Nonrefillable ainer. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete Fill the container 1/4 full with water. Heplace and tighten closures. Add the rinsate to the spray tank and dispose of the outer pouch as described previously.
