TERRESTRIAL NONFOOD CROPS – Non-cropland, grasses (on acreage enrolled in the Conservation Reserve Program) and tree plantings.

2. Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration.

3. Uses for experimental purposes that are in compliance with USEPA requirements.

### STORAGE AND DISPOSAL

**STORAGE:** Store product in original container only. Do not contaminate water, other pesticides, fertilizer, food or feed in storage.

**DISPOSAL:** Do not contaminate water, food or feed by disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER DISPOSAL:** Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into manufacturing equipment.
