Dear Ms. Rodriguez:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable, provided you make the following changes:

1. Change the heading from "Inert Ingredients" to **"Other Ingredients"**.
2. Change the Precautionary Statement from "Wash thoroughly after handling." to **"Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet."**
3. Change the Pesticide Disposal statement to read "Wastes resulting from the use of this product **must** be disposed of on site or at an approved waste disposal facility."

A stamped copy of your label is enclosed for your records. This label supercedes all previously accepted labels. You must submit one (1) copy of the final printed label before you release the product for shipment. Products shipped after eighteen (18) months from the date of this letter or the next printing of the label, whichever occurs first, must bear the new revised label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA §6(e). Your release for shipment of the product constitutes acceptance of these conditions.

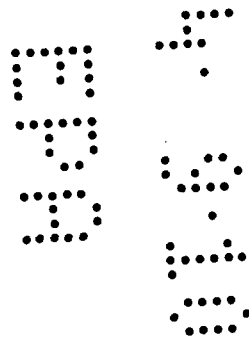

DuPont™ Chlorimuron Ethyl Technical herbicide is to be used only for the formulation of end-use herbicide products registered for the following uses:

1. **Terrestrial Food Crops** – Opitnum® GAT® field corn, Opitnum® GAT® soybeans, field corn, Soybeans and Peanuts
2. **Terrestrial Noncrop Uses**
3. Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration.
4. Uses for experimental purposes that are in compliance with USEPA requirements.

Formulators using this product are responsible for obtaining EPA registration for their formulated products.



STORAGE AND DISPOSAL

Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then, for Plastic Containers, offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration. Do not burn, unless allowed by state and local ordinances. For Metal Containers, offer for recycling if available or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Nonrefillable Plastic and Metal Containers, e.g., Intermediate Bulk Containers [IBC] (Size or Shape Too Large to be Tipped, Rolled or Turned Upside Down): Nonrefillable container.
