

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Du Pont "Assure" II Herbicide is recommended for postemergence usage to control certain grasses on noncrop sites such as fence rows, roadsides, equipment storage areas, and other similar areas.

Since "Assure" II Herbicide (as registered) controls many grasses but not most broadleaf plants, it may be used to enhance establishment and growth of certain broadleaf plants on non-crop sites (that is, plants identified as "wildflowers" such as indian blanket, cone flowers, bachelor button, dwarf cornflower, coreopsis, white yarrow, oxeye daisy, damesrocket, blue flax, eveningprimrose, blackeyed-susan, marigolds, impatiens, bluebonnet, indian paintbrush, verbena, gaillardia, chrysanthemum, catchfly and scarlet pimpernel).

HOW TO USE

To aid in the establishment of broadleaf wildflowers, apply 5 to 10 fl. ozs "Assure" II per acre (plus a nonionic surfactant).

Apply postemergence to early growth stages of the grasses to be controlled (see container labeling).

APPLICATION AND MIXING

Use a spray volume of no less than 10 nor more than 40 gallons water per acre.

Mix the selected rate of "Assure" II (5 to 10 fl. ozs.) in the per acre spray volume chosen (10 - 40 gals); add a nonionic surfactant (80% active) at 1 to 2 pts per 100 gals spray mix.

Use flat fan nozzles and thoroughly cover the grass foliage.

Note: Do not allow spray to drift onto adjacent crops as injury to plants (other than soybeans) will likely occur. When spraying close to adjacent crops or plants, do everything possible to reduce the occurrence of off-target spray movement such as:

- Increase spray volume.
- Use lower sprayer pressure (but not less than 20 psi).
- Add an appropriate drift control agent.
- Stop spraying if wind speed becomes excessive.
