STORAGE AND DISPOSAL

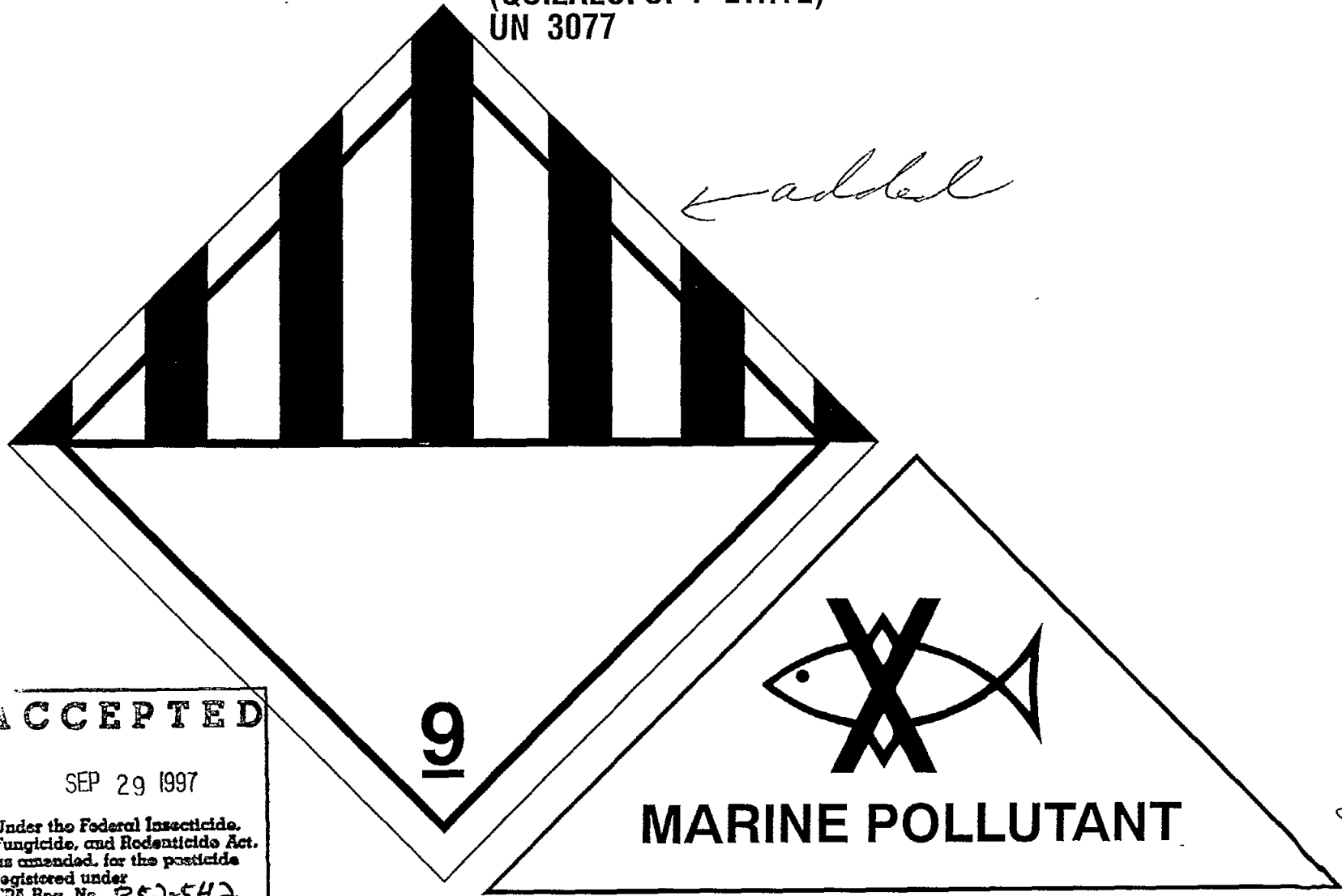
