STORAGE AND DISPOSAL

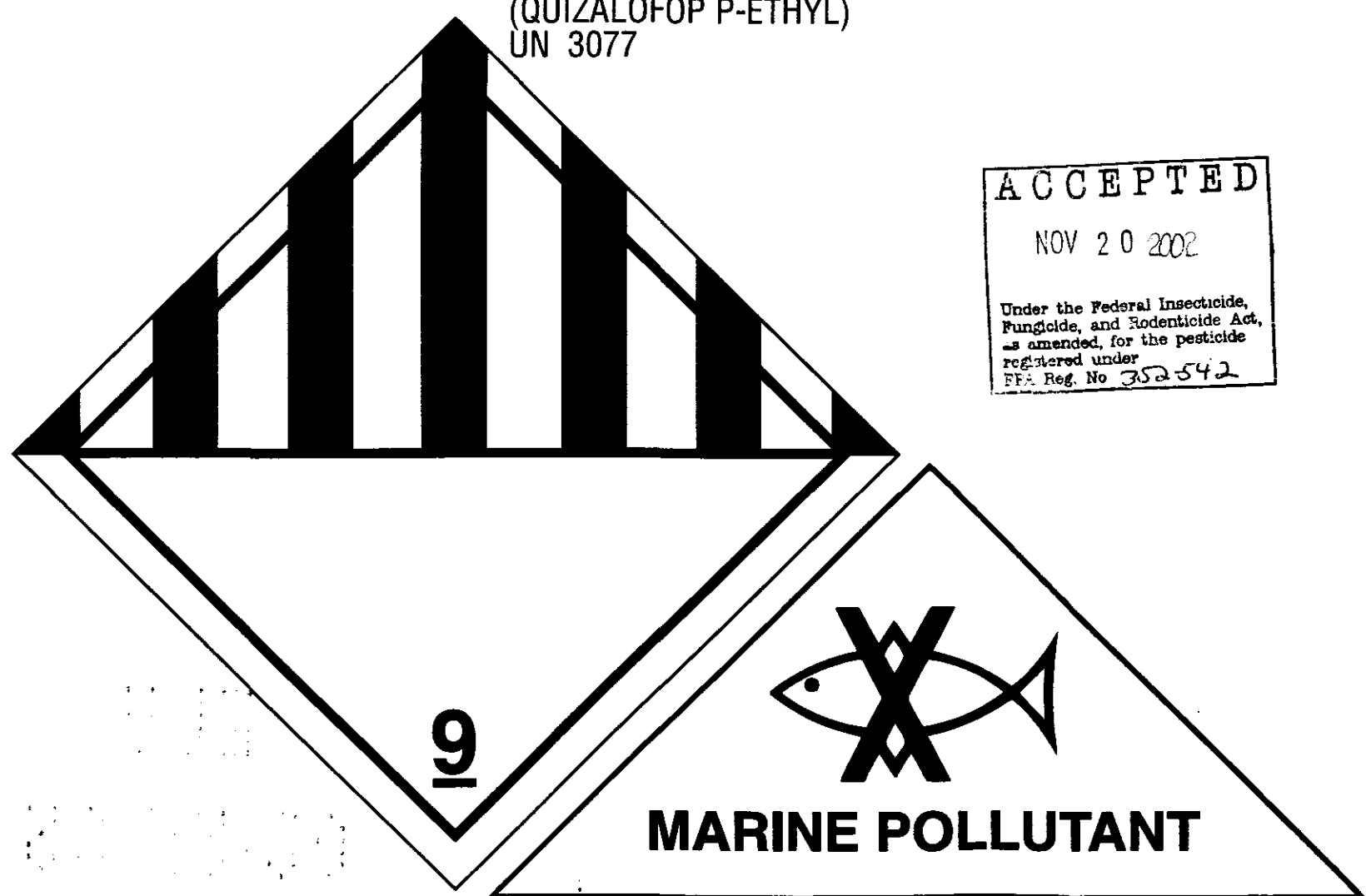
STORAGE: Store product in original container only. Do not contaminate water, other pesticides, fertilizer, food or feed in storage.
