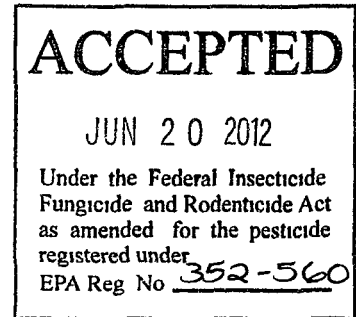

**DIRECTIONS FOR USE**

DuPont™ ACCENT® herbicide may be used for postemergence control of certain perennial and annual grasses on noncrop sites including fence rows, roadsides, equipment storage areas and other similar areas. It may also be used selectively in established bermudagrass rough turf for control of weeds listed.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

ACCENT® herbicide must only be used in accordance with the directions on this label, or in separately published DuPont directions.

**APPLICATION INFORMATION**

Apply by ground using a minimum of 15 gallons of spray per acre. Use flat fan nozzles, directing the spray to plant foliage, use a spray volume that will thoroughly cover plant foliage.

Use the spray preparation of ACCENT® within 24 hours as product degradation may occur. If spray preparation is left standing, agitate before rinsing.

For control of johnsongrass, shattercane, sorghum alnum, apply 1 to 1.5 ounces of ACCENT® per acre (plus surfactant\*) to plants 8 to 10 inches tall.

Alternatively, for rhizome johnsongrass, use a split application of 0.75 ounces of ACCENT® per acre on plants 8 to 10 inches tall for both treatments

For control of quackgrass, apply 1 ounce of ACCENT® per acre (plus surfactant\*) to growth 2 to 4 inches tall

For control of foxtail, tall panicum, Texas panicum, barnyardgrass, broadleaf signalgrass, sandbur and woolly cupgrass, apply 1 to 1.5 ounces of ACCENT® per acre (plus surfactant\*) to plants 2 to 6 inches tall. If larger plants are treated, they will be stunted, but not killed.

For selective use in established bermudagrass rough turf (industrial, unimproved only) Apply 1 to 1.5 ounces of ACCENT® per acre (plus surfactant\*) to plants 2 to 6 inches tall. If larger plants are treated, they will be stunted but not killed.

\*Add nonionic surfactant at 0.25% v/v (1 quart per 100 gallons spray solution)
