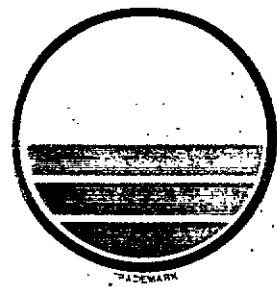

The fertilizer must be added in addition to the crop oil concentrate. Do not apply less than 14 ounces of BASIS GOLD per acre.

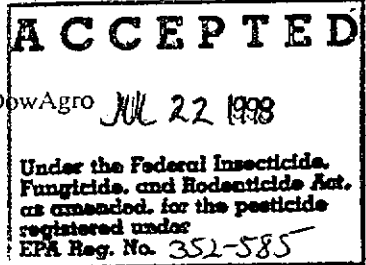

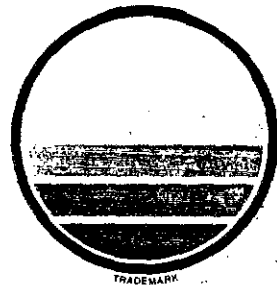

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DuPont BASIS GOLD Herbicide may be used as a sequential treatment in a planned postemergence weed control program in corn following a reduced rate of a preemergence herbicide. BASIS GOLD may be tank mixed with labeled broadleaf herbicides such as atrazine and Banvel (1) or Clarity (1) for additional broadleaf weed control. Refer to the BASIS GOLD label for a complete list of broadleaf tank mix herbicides.

WHEN TO APPLY

Apply any of the following preemergence herbicides prior to corn emergence.

BASIS GOLD performs best when applied to small, actively growing grasses, oftentimes 30-45 days after corn planting. Apply BASIS GOLD (with or without a labeled broadleaf herbicide) at a rate of 14 ounces per acre. Consult the BASIS GOLD label for a complete listing of grasses controlled and the labeled sizes.

Do not apply less than 14 ounces of BASIS GOLD per acre.

Always add a crop oil concentrate or methylated seed oil to BASIS GOLD at a rate of 1 gallon per 100 gallons of spray solution (1% v/v). In addition, add an ammonium nitrogen fertilizer such as 28-0-0 to the spray tank. See the BASIS GOLD label for additional information on ammonium fertilizer types and rates.

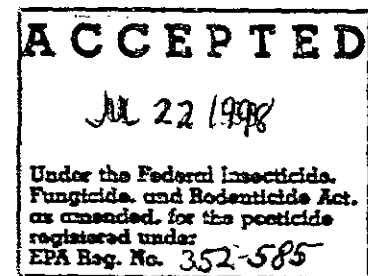
