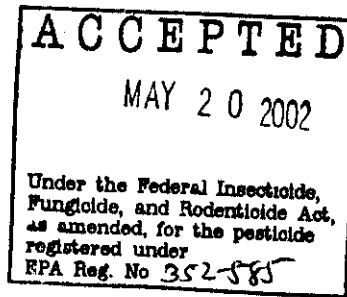

This product is a restricted use herbicide due to ground and surface water concerns. Users must read and follow all precautionary statements and instructions for use on the container label in order to minimize potential for atrazine to reach ground and surface water.

DIRECTIONS FOR USE

DuPont BASIS GOLD® Herbicide may be tank mixed with 2.0-3.0 ounces active per acre of dicamba (e.g. 4.0-6.0 fluid ounces per acre of "Clarity") for additional control of palmer pigweed when applied to field corn. Do not apply to field corn grown for seed, to popcorn or to sweet corn.

WHEN TO APPLY

Postemergence applications of BASIS GOLD® Herbicide plus dicamba, should be made to corn that is 4-8" tall and is exhibiting fewer than 4 leaf-collars. See the BASIS GOLD® label for sizes of grasses and other broadleaf weeds controlled.

HOW TO USE

BASIS GOLD® performs best when applied to young, actively growing grasses and weeds. An activating rainfall (>1/2") is required shortly after application for maximum residual activity. Use a minimum of 15 gallons of water per acre (15 GPA) for best results. Apply 14 ounces of BASIS GOLD® per acre.

SPRAY ADDITIVES

Add an ammonium nitrogen fertilizer such as 28-0-0 (2-4 qts/acre), 10-34-0 (1-2 qts/acre) or spray grade ammonium sulfate (21-0-0) at 2-4 lbs/acre plus methylated seed oil (MSO) at 1% v/v (1 gal/100 gal spray solution).

IMPORTANT PRECAUTIONS

Refer to the BASIS GOLD® and dicamba labels for additional use directions, restrictions, rotational crop intervals and precautions. The most restrictive provision on either tank mix partner label shall apply. Do not apply BASIS GOLD® through any type of irrigation system.
