
1. Delete the company name "DUPONT" from the heading of the product name so that it reads "Curzate 60DF".
2. Within the "Application Information" section, 1st bullet, delete the company name "Dupont" from the product name so that the sentence reads "Apply Curzate 60DF plus a protectant fungicide on a 5-7 day schedule."
3. Within the "Application Information" section, 2nd bullet, revise the sentence to read "Do not apply more than 30 oz. of Curzate 60 DF per 12 month period."
4. Revise the sentence "This supplemental label expires on 8/13/2013" to read "This supplemental label expires on 8/13/2013 and must not be used or distributed after this date."
5. Revise the sentence "Read the Limitation of Warranty..." to read "Read the Limitation of Warranty and Liability on the container label..."

One copy of the supplemental label stamped "Accepted with comments" is enclosed for your records. This supplemental labeling must be incorporated into the master label within 18 months or at your next label printing, whichever comes first. Please submit

Use 5.0 oz per acre for control of spinach downy mildew (*Peronospora farinosa*). Use only in a combination with a labeled rate of a protectant fungicide, such as copper-containing products for spinach and lettuce.
