
The amendment referred to above, submitted in connection with registration under the FIFRA as amended is acceptable provided that you:

1. Submit the following information and/or data within sixty days from the date of this letter.
 - a. The full Optimum GAT soybean metabolism study as specified in 860.1300.
 - b. The ruminant and poultry metabolism studies referenced in the livestock validation study (MRID 47311011; dosed with ¹⁴C-N-acetyl-glyphosate).
 - c. The ruminant and poultry feeding studies referenced in the livestock validation study (MRID 47311011; dosed with N-acetyl-glyphosate).
2. Submit and/or cite all data required for registration/reregistration of your product when the Agency requires all registrants of similar products to submit such data.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of labeling is enclosed for your records.

PRE-PLANT BURNDOWN IN GLYPHOSATE TOLERANT SOYBEANS

DuPont Staple Plus Herbicide is a unit area package which consists of a water soluble powder packet and a liquid in a bottle, separated by a plastic insert. One container of DuPont Staple Plus herbicide will treat 10 acres.

This product may be applied for burndown of emerged weeds before planting glyphosate tolerant soybeans.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DuPont Staple Plus Herbicide may be used as a pre-plant burndown treatment alone or in combination with other suitable registered herbicides.

Read and follow all manufacturers label recommendations for any companion herbicide(s). If those recommendations conflict with this label, do not tank mix the herbicide(s) with DuPont Staple Plus Herbicide.

In fields to be planted to glyphosate tolerant soybeans, apply DuPont Staple Plus Herbicide at a rate of one container per 10 acres.

Allow at least 10-months between application and planting of glyphosate tolerant soybeans.

The use of adjuvants may help improve weed control under certain adverse weather conditions such as arid/dry, excessive heat, etc. If another herbicide is tank mixed with DuPont Staple Plus Herbicide to increase the broadleaf weed spectrum, select adjuvants based on the adjuvant limitations of the companion herbicide.

RESTRICTIONS

- DO NOT apply later than 10-months before planting glyphosate tolerant soybeans.
