DuPont STEADFAST™ Herbicide may be tank mixed with 2 oz of Distinct Herbicide or 4-8 oz Clarity Herbicide for additional control of broadleaf weeds when applied to field corn. Do not apply to field corn grown for seed, to popcorn or to sweet corn.

WHEN TO APPLY

Postemergence applications of STEADFAST™ plus Distinct or Clarity should be made to corn that is 4-12" tall and is exhibiting fewer than 6 leaf-collars. See the STEADFAST™ label for sizes of grasses and other broadleaf weeds controlled.

HOW TO USE

STEADFASTTM performs best when applied to young, actively growing grasses and weeds. An activating rainfall (>1/2") is required shortly after application for maximum STEADFASTTM residual activity.
