WHEN TO APPLY

Postemergence applications of STEADFASTTM + Callisto may be broadcast to corn up to 20" tall, up to and including 6 leaf collars (V6), whichever is more restrictive. Tank mixes with atrazine are limited to 12" tall corn. See the STEADFASTTM labels for a list of grasses controlled and sizes for application.

HOW TO USE

Apply 0.75 ounces of STEADFAST™ in combination with rates of Callisto listed above for the control of grasses and broadleaf weeds. STEADFAST™ performs best when applied to young, actively growing grasses and broadleaf weeds. Use a minimum of 15 gallons of water per acre (15 GPA) for best results.

SPRAY ADDITIVES

Add an ammonium nitrogen fertilizer such as 28-0-0 (2-4 qts/acre), 10-34-0 (1-2 qts/acre), or spray grade ammonium sulfate (21-0-0) at 2-4 lbs/acre plus a petroleum-based crop oil concentrate (COC) at 1%v/v (1 gal/100 gal spray solution).
