GENERAL INFORMATION

DuPont™ ADVION™ Cockroach Bait Stations contain cockroach bait material that contains the active ingredient indoxacarb, an insecticide that acts through ingestion by cockroaches. The activity of this insecticide allows adequate consumption of the bait by cockroaches prior to onset of mortality.

ADVION™ Cockroach Bait Stations can be used indoors to control cockroach populations. Stations should be placed in/or near cockroach harborage areas or areas known to be frequented by cockroaches.

Outdoors, bait stations should be placed adjacent to structures.

SPECIFIC USE DIRECTIONS

1. Thoroughly inspect infested area to determine proper ADVION™ Cockroach Bait Station placement and number of stations necessary to treat the area.
2. Enough ADVION™ Cockroach Bait Stations must be used to provide adequate bait to control the cockroach populations present. Recommended placements: Place 3-10 bait stations per 100 linear feet of horizontal surface primarily around wall perimeters and other areas away from walls such as but not limited to, around centrally located island sinks, cabinets, and appliances. Place maximum number of ADVION™ Cockroach Bait Stations with heavy cockroach infestations.
3. Place ADVION™ Cockroach Bait Stations in areas where cockroaches frequent such as along walls or corners, under or near kitchen appliances and industrial equipment, under sinks, in cabinets, and utility areas.
4. Each ADVION™ Cockroach Bait Station may be vertically or horizontally applied by removing the protective paper from the bottom of the station exposing the adhesive. Use of additional adhesives may be necessary on some surfaces.
5. Inspect ADVION™ Cockroach Bait Stations periodically and replace depleted bait stations as needed based on severity of the initial cockroach infestation and a continuing control program.
6. Avoid direct contact of ADVION™ Cockroach Bait Stations with broadcast, spot or crack and crevice directed pest control applications.
