Remove contaminated clothing and wash clothing before reuse. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."
3. Submit two copies of the revised final printed label for the record before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Additionally, in the acute toxicity review dated 7/16/04, EPA indicated that if you reformulate the product in the future, the Agency will need to reassess the acute inhalation waiver granted for this product. A reassessment also applies if you or another party cites the acute toxicity data to support or claim similarity to the subject product. Please reference the acute toxicity review previously sent to you in a letter dated 8/5/04.
