#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

AFFINITY® TANKMIX, AFFINITY® BROADSPEC or ALLY® EXTRA can be tank mixed with 7 to 14 fluid ounces per acre of CLEANWAVE herbicide for improved Kochia and broadleaf weed control in wheat. Apply from the 3-leaf crop growth stage through early jointing (Zadoks scale 30).
