CROP ROTATION

Minimum Rotation Intervals

Minimum rotation intervals* are determined by the rate of breakdown of GLEAN® XP applied. GLEAN® XP breakdown in the soil is affected by soil pH, soil temperature, and soil moisture. Low soil pH, high soil temperature, and high soil moisture increase GLEAN® XP breakdown in soil, while high soil pH, low soil temperature, and low soil moisture slow GLEAN® XP breakdown.

Of these 3 factors, only soil pH remains relatively constant. Soil temperature, and to a greater extent, soil moisture, can vary significantly from year to year and from area to area. For this reason, soil temperatures and soil moisture should be monitored regularly when considering recropping.

*The minimum rotation interval represents the period of time from the last application to the anticipated date of the next planting.

Soil pH Limitations

GLEAN® XP should not be used on soils having a pH above 7.9, as extended soil residual activity could extend crop rotation intervals beyond normal, and under certain conditions, could injure wheat, barley, or oat. In addition, other crops planted in high-pH soils can be extremely sensitive to low concentrations of GLEAN® XP.

Checking Soil pH

Before using GLEAN® XP, determine the soil pH of the areas of intended use. To obtain a representative pH value for the test area, take several 0" to 4" samples from different areas of the field and analyze them separately. Consult local extension publications for additional information on recommended soil sampling procedures.
