The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments below.

- 1. Within the LIMITATION OR WARRANTY AND LIABILITY section of the label, revise the sentence "DUPONT MAKES NO OTHER EXPRESS OR IMPLIED ..." to read "TO THE EXTENT CONSISTENT WITH APPLICABLE LAW, DUPONT MAKES NO OTHER EXPRESS OR IMPLIED..."
- 2. Within the LIMITATION OR WARRANTY AND LIABILITY section of the label, revise the sentence "THE EXCLUSIVE REMEDY OF THE USER OR BUYER..." to read "TO THE EXTENT CONSISTENT WITH APPLICABLE LAW, THE EXCLUSIVE REMEDY OF THE USER OR BUYER..."
- 3. Within 3 years of the date of this letter, data on aquatic and terrestrial plants (as outlined in the Agency memorandum dated August 24, 2007) must be submitted to the Agency. DuPont must provide a signed letter within 10 days of this approval, agreeing to satisfy all confirmatory data requirements.
- 4. Within 3 years of the date of this letter, data on acute and chronic toxicity to soil ingesting benthic animals (as outlined in the Agency memorandum dated August 24, 2007) must be submitted to the Agency. DuPont must provide a signed letter within 10 days of this approval, agreeing to satisfy all confirmatory data requirements.

A stamped copy is enclosed for your records. Please submit one (1) final printed copy for the referenced label, incorporating the above changes, before releasing the product for shipment.
