Dear Mr. Bockrath:

The supplemental labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable, provided you make the following changes:

1. Revise the rate unit from "8.5 oz/a" to "8.5 fl oz/a" and from "20 oz/a" to "20 fl oz/a".
2. Revise the trademark reference from "Bayer Aktiengesellschaft" to "Bayer CropScience".

At your next label printing, or within eighteen (18) months of the date of this letter, whichever comes first, you must incorporate this supplemental labeling into the main product labeling.

A stamped copy of your label is enclosed for your records. You must submit one (1) copy of the final printed label before you release the product for shipment. Products shipped after eighteen (18) months from the date of this letter or the next printing of the label, whichever occurs first, must bear the new revised label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA §6(e). Your release for shipment of the product constitutes acceptance of these conditions.

AFFINITY® TANKMIX at 0.6 oz/a to 1.0 oz/a or AFFINITY® BROADSPEC at 0.4 to 1.0 oz/a can be tank mixed with Huskie at 8.5 oz/a or Wolverine at 20 oz/a in wheat, durum, or barley for control of broadleaf weeds, including kochia (less than 2" in height). It is a violation of federal law to use this product in a manner inconsistent with its labeling.

SURFACTANTS

Unless otherwise specified, add a DuPont recommended non-ionic surfactant having at least 80% active ingredient at 1 to 2 pints per 100 gal of spray solution (0.125 to 0.25%, v/v) when AFFINITY® TANKMIX or AFFINITY® BROADSPEC is used in a tank mix with Huskie or Wolverine.

Contact your agricultural dealer, applicator, or DuPont representative for a listing of recommended surfactants. Antifoaming agents may be used if needed.

Do not use low rates of liquid nitrogen fertilizer solution as a substitute for surfactant.
