FIRST AID

STORAGE: Material crystallizes below 32°F. Do not heat above 176°F. Do not use with mild steel or acid-sensitive resins such as delrin and celcon. Do not expose nylon to undiluted UREA SULFATE - MP. UREA SULFATE - MP is moderately corrosive to cast iron, aluminum, and brass. Prolonged use with these materials is not recommended.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law.
