Dear Mr. Ambrose:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable, provided you make the following changes:

1. Change the PESTICIDE DISPOSAL sentence to read "Wastes resulting from the use of this product **must** be disposed of on site or at an approved waste disposal facility."
2. Add the phrase "TO THE EXTENT CONSISTENT WITH APPLICABLE LAW" directly in front the following warranty/liability statements:
 "DUPONT MAKES NO OTHER EXPRESS OR IMPLIED WARRANTY..."
 "THE EXCLUSIVE REMEDY OF THE USER OR BUYER..."

A stamped copy of your label is enclosed for your records. This label supercedes all previously accepted labels. You must submit one (1) copy of the final printed label before you release the product for shipment. Products shipped after eighteen (18) months from the date of this letter or the next printing of the label, whichever occurs first, must bear the new revised label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA §6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Terrestrial Crops: Alfalfa, Artichoke (California), Asparagus, Winter Barley, Birdsfoot Trefoil, Corn (Field), Cotton, Grass Seed Crops, Oats, Peppermint, Red Clover, Sorghum (Grain), Sugarcane, Winter Wheat, Apples, Bananas and Plantains, Blueberries, Caneberries and Gooseberries, Citrus, Grape, Macadamia Nuts (Hawaii), Olives, Papayas, Peaches, Pears, Pecans, Pineapple (Hawaii and Florida), Walnuts (California).

Terrestrial Non-Crops: Utility, Highway, Pipeline and Railroad Right-of-Ways, Petroleum Tank Farms, Lumberyards, Storage Areas, Industrial Plant Sites and around Farm Buildings.

Aquatic Non-Crops: Irrigation and Drainage Ditches.

Nonrefillable Plastic and Metal Containers (Capacity Greater Than 50 Pounds):

Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then, for Plastic Containers, offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration. Do not burn, unless allowed by state and local ordinances.
