- d. Revise "FOR USE BY COMMERCIAL APPLICATORS ONLY" to read "INTENDED FOR USE BY COMMERCIAL APPLICATORS ONLY."
- e. On the front page of the label, include the company name and complete address.
- f. On page 5 of the label, delete the phrase "Optional label language." Please note that all label language must be approved by the Agency.
- g. Within the **STORAGE AND DISPOSAL** section of the label, revise "**STORAGE**" to read "**PESTICIDE STORAGE**."
- 3. The data requirements for storage stability (830-6317) and corrosion characteristics (830-6320) have not been satisfied, and must be submitted within eighteen months of the date of this letter.
- 4. Submit one copy of the revised final printed label for the record before you release the product for shipment.

DuPontTM E2Y45 0.33G insecticide may be applied for the control of white grubs and other pests infesting landscape and recreational turfgrass (including golf courses) as well as landscape ornamentals and interior plantscapes.

DuPont™ E2Y45 0.33G insecticide may be used on plants or turfgrasses that are being grown for aesthetic or recreational purposes or climatic modification in or around home lawns, commercial lawns, industrial facilities, residential dwellings, business and office complexes, shopping complexes, multi-family residential complexes, institutional buildings, airports, cemeteries, interior plantscapes, ornamental gardens, wildlife plantings, parks, wildlife plantings, playgrounds, schools, day-care facilities, golf courses (tee box areas, roughs, fairways, greens, collars etc.), athletic fields, sod farms and other landscaped areas.

DuPont™ E2Y45 0.33G insecticide should not be applied when the soil is saturated with water because adequate distribution of the active ingredient vertically in the soil profile cannot be achieved under this condition.

DuPont™ E2Y45 0.33G insecticide is in GROUP 28 of the EPA's Insecticide and Acaricide Groups Based on Target Site of Action (EPA PR Notice 2001-5) and may be used in rotational resistance management programs.

APPLICATION EQUIPMENT

DuPont™ E2Y45 0.33G insecticide may be applied with drop-type, rotary-type or hand-held application equipment. The application equipment should be properly calibrated according to the manufacturer's directions to ensure uniform coverage over the treated area. During application, the equipment should be checked periodically to confirm that it is working properly and that the granules are being uniformly distributed.

APPLICATION TIMING

White Grubs: DuPontTM E2Y45 0.33G insecticide may be applied from early April to early September for preventative and early curative control all of the major white grub species infesting turfgrass. The need for an application may be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. The higher rate listed for white grub control in Table 1 may be required for early season (April and May) applications where a long residual is required or in late August or early September when less sensitive mid-instar grubs are present at the time of application. As is the case with any insecticide applied to turfgrass for white grub control, optimal results will be achieved if the product is irrigated into the turf immediately after application.

Annual Bluegrass Weevil: DuPontTM E2Y45 0.33G insecticide should be applied when overwintered adult annual bluegrass weevils are observed in late April or early May to prevent damage from first generation larvae in late-May and June. An application of DuPontTM E2Y45 0.33G insecticide at this time will also provide white grub control. The higher rates listed in Table 1 may be required for applications made after mid-May.

Billbugs: DuPontTM E2Y45 0.33G insecticide should be applied when overwintered adult billbugs are first observed. This will usually occur in late April or early May in regions with cool-season turfgrasses. An application of DuPontTM E2Y45 0.33G insecticide at this time will also provide white grub control. The higher rates listed in Table 1 may be required for applications made after early May or when billbug species other than bluegrass billbug are present.

European Crane Fly: DuPontTM E2Y45 0.33G insecticide should be applied between September and November to control European crane fly larvae in turfgrass. The higher rate listed in Table 1 may be required to achieve control when applications are made in November.

Spittlebugs: DuPont™ E2Y45 0.33G insecticide will provide control of two-lined spittlebug when applications are made in spring or summer.

Turf Caterpillars: DuPont™ E2Y45 0.33G insecticide will provide curative caterpillar control in turfgrass. If the area being treated is maintained at a mowing height of greater than one inch, then the higher rate listed in Table 1 may be required during periods of high pest pressure.

Chinch Bugs: For suppression of chinch bugs, apply DuPont™ E2Y45 0.33G insecticide before eggs hatch.

APPLICATION RATES FOR LAWNS, GOLF COURSES AND OTHER RECREATIONAL TURFGRASS AREAS

Table 1 provides the application rates that will control the listed turfgrass pests. For maximum residual effectiveness or for optimal control of large pest infestations, apply DuPontTM E2Y45 0.33G insecticide at up to 100 pounds per acre (0.33 lb AI/A) to control any of the pests listed in Table 1. Do not apply more than 150 pounds (equivalent to 0.5 lb of active ingredient) of product per acre per year in broadcast applications to turfgrass.

APPLICATION RATES FOR ORNAMENTAL PLANTS

Table 2 provides the application rates that will control the pests of landscape ornamentals and interior plantscapes. Black plastic or other weed barrier materials that are imper-

meable to water should be removed before application. For maximum residual effectiveness or for optimal control of large pest infestations, DuPontTM E2Y45 0.33G insecticide may be applied at up to 100 pounds per acre (0.33 lb AI/A) to control any of the pests listed in Table 2.

DuPont™ E2Y45 0.33G insecticide will reduce the target pest species that may serve as a food source for beneficial arthropods.
