CROP ROTATION

Minimum Rotation Intervals

Labelled crops may be planted at specified time intervals following application of labelled rates of DuPontTM FIRSTSHOT® SG burndown herbicide (with TotalSol® soluble granules). In the states of Alabama and Georgia, peanuts can be planted 30 days after a burndown treatment with FIRSTSHOT® SG. Where FIRSTSHOT® SG is used on light textured soils, such as sands or loamy sands, extend time to planting by 7 additional days. Where FIRSTSHOT® SG is used on high pH soils (>7.9), extend time to planting by 7 additional days.

BEFORE USING FIRSTSHOT® SG BURNDOWN HERBICIDE, READ AND FOLLOW ALL APPLICABLE DIRECTIONS, RESTRICTIONS AND PRECAUTIONS ON THE EPA-REGISTERED LABEL.
