  - c. Submit five-batch analysis from commercial-scale production of the product.
- 3. Submit a repeated-dose study in a sensitive species to address the hazard of chronic exposure to the environmental degradate cyclopropane carboxylic acid (IN-V0977) within two (2) years from the date of this notice.
- 4. Submit the following environmental effects studies on aminocyclopyrachlor within **two (2) years** from the date of this notice:
  - a. Guideline 850.2300: Avian Reproduction Toxicity Test
  - b. Guideline 850.1300: Freshwater Invertebrate Life Cycle Toxicity Test

Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then, for Plastic Containers, offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration. Do not burn, unless allowed by state and local ordinances. For Metal Containers, offer for recycling if available or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities

and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Nonrefillable Paper or Plastic Bags, Fiber Sacks including Flexible Intermediate Bulk Containers (FIBC) or Fiber Drums With Liners: Nonrefillable container. Do not reuse or refill this container.
