On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

- 1. Submit and/or cite all data required for registration review of your product when the Agency requires all registrants of similar products to submit data.
2. Submit the following product chemistry studies within one (1) year from the date of this notice:
a. Guideline 830.6317: Storage Stability
b. Guideline 830.6320: Corrosion Characteristics
c. Submit five-batch analysis from commercial-scale production of the product.
3. Submit a repeated-dose study in a sensitive species to address the hazard of chronic exposure to the environmental degradate cyclopropane carboxylic acid (IN-V0977) within two (2) years from the date of this notice.
4. Submit the following environmental effects studies on aminocyclopyrachlor within two (2) years from the date of this notice:
a. Guideline 850.2300: Avian Reproduction Toxicity Test
b. Guideline 850.1300: Freshwater Invertebrate Life Cycle Toxicity Test
