On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is registered under 3(c)(5) with the following terms and conditions:

- 1. This registration will automatically expire three (3) years from the date the amendment is granted, unless DuPont has been informed by EPA in writing that this condition of registration has been amended.
- 2. DuPont will not sell, distribute, or market DuPont Imprelis Herbicide (EPA Reg. No. 352-793) for sale or use by any other person, except in compliance with an order issued by EPA, or until DuPont has been informed by EPA in writing that this condition of registration has been amended.

- 3. DuPont will report all previously-unreported adverse-effects related information related to incidents that would otherwise be reportable under 40 C.F.R. § 159.184, resulting from the use of Imprelis Herbicide (EPA Reg. No. 352-793) to the Office of Pesticide Programs (OPP) under the following schedule:
  - For the month of August 2011, provide OPP with a report on or before the 30<sup>th</sup> day that includes any previously-unreported adverse incidents information reported to or discovered by DuPont on or before August 15<sup>th</sup>, 2011.
  - For the months of September and October 2011, provide OPP with a report on or before the 15<sup>th</sup> and 30<sup>th</sup> days of each month that includes any previously-unreported adverse incidents information reported to or discovered by DuPont on or before the 1<sup>st</sup> or 15<sup>th</sup> day of each month, respectively.
  - For the months of November and December 2011, and January 2012, provide OPP with a report on or before the 30<sup>th</sup> day of each month that includes any previously-unreported adverse incidents information reported to or discovered by DuPont by the 15<sup>th</sup> day of each month.
  - Any information in Paragraph 3 above to be reported beginning in February 2012, will be provided to OPP with bi-monthly reports submitted on or before the last day of the second month (starting with a report on March 31, 2012), and shall include all previously-unreported adverse incidents information reported to DuPont on or before the 15<sup>th</sup> day of the month in which the report is to be submitted.
- 4. DuPont will report all adverse effects-related incident information required to be reported to EPA under Paragraph 3 in a spreadsheet format and address as many of the following data fields as possible for each incident; however, DuPont is only required to provide information in those data fields to the extent that the information is reported to, or otherwise known to, DuPont; this provision does not require DuPont to conduct an investigation to obtain any such information that it does not otherwise possess:
  - Application rate
  - Application area (acres)
  - Application site (turf/noncrop)
  - Application method (ground/aerial)
  - Date of incident (noticed by landholder)
  - Date of incident (reported)
  - Species involved
  - Number of non-target individuals (per species)
  - Phytotoxic response observed (e.g. turned brown over several hours resulting in mortality)
  - Proximity of affected non-target species to application site
  - Affected plants upslope or downslope of application area
  - How many applications prior to incident reporting
  - Whether residues are detected in the soil and the results of such sampling
  - Whether residues are in affected plant tissue
  - Irrigation or rain events and amounts after application
  - If irrigated, whether the water is from a water recovery reservoir/pond

• Whether grass clippings or mulch from treated turf was applied around affected plants prior to observed injury

In the event that after August 30, 2011, DuPont discovers new information that would alter an entry earlier reported to EPA in its spreadsheets, DuPont will provide EPA with updated spreadsheet entries in its next scheduled submission and will clearly mark the changes made.

- 5. DuPont will not change the source of, or obtain from an alternate supplier, Technical aminocyclopyrachlor for formulation into the Imprelis end-use product without first applying for an amendment to include the alternate source or supplier as an approved source, and not before such amendment has been granted.
- 6. In accordance with the disposition plan that must be submitted to EPA for approval, DuPont will maintain specific records on the volume of Imprelis product returned, and its location(s) and status when in DuPont's possession. All such records shall be made available to EPA upon request.
