# **PRODUCT INFORMATION**

DuPont<sup>TM</sup> LEADOFF<sup>TM</sup> herbicide must be used only in accordance with instructions on this label or in supplemental DuPont publications. DuPont will not be responsible for losses or damage resulting from use of this product in any manner not specifically specified by DuPont.

LEADOFF<sup>TM</sup> herbicide is a water soluble granule containing 33.4% active ingredient by weight. LEADOFF<sup>TM</sup> is a selective herbicide for burndown and residual control of certain annual grass and broadleaf weeds when applied preplant or preemergence to field corn. It may also be applied 30 days or more preplant to cotton or soybeans for winter vegetation management. Residual weed control is dependent on rainfall or sprinkler irrigation for herbicide activation. LEADOFF<sup>TM</sup> herbicide may be applied in tank mixtures with other herbicides labeled for use in the intended crop. However, in the case of tank mixes with other herbicides, the most restrictive label must be followed.

LEADOFF<sup>TM</sup> is absorbed through the roots and leaf tissue of plants, rapidly inhibiting the growth of susceptible weeds. Rainfall or sprinkler irrigation is needed to move LEADOFF<sup>TM</sup> into the soil. Susceptible weeds will generally not emerge from preemergence application. In some cases susceptible weeds may germinate and emerge a few days after application, but growth then ceases and leaves become chlorotic three to five days after emergence. Death of leaf tissue and growing point will follow in some species, while others will remain green but stunted and noncompetitive.

The herbicidal action of LEADOFF<sup>TM</sup> may be less effective on weeds stressed from adverse environmental conditions (such as extreme temperatures or moisture), abnormal soil conditions, or cultural practices.

# **APPLICATION INFORMATION**

#### Field Corn - Preplant-Preemergence

#### Rate

Apply DuPont<sup>™</sup> LEADOFF<sup>™</sup> at 1.5 - 2.7 ounces per acre.

DuPont specifies a use rate of 1.5 oz per acre for most applications. Consult DuPont technical bulletins for additional application rates. See cumulative rimsulfuron rate limitations noted in this label.

Not all field corn varieties have been tested; nor does DuPont have access to all seed company data. Consequently; DuPont is not responsible for any crop injury arising from the use of LEADOFF<sup>TM</sup> on field corn. When tank mixing check the tank mix partner label for tolerances and instructions for use. In addition; consult with your local DuPont representative or the DuPont Label Web Site (http://cropprotection.dupont.com/) for any additional supplemental labeling information relative to potential corn hybrid sensitivity to LEADOFF<sup>TM</sup>.

#### **Timing to Crop**

LEADOFF<sup>TM</sup> may be applied preplant after fall harvest through early spring, up to planting, whenever the ground is not frozen, to control emerged weeds and to provide limited residual control of early-emerging spring weeds.

Additionally, LEADOFFTM may be applied anytime after planting, but before corn emergence.

Do not apply postemergence to corn.

Control of emerged weeds will require the addition of spray adjuvants as noted in this label.

#### **Sequential Application**

LEADOFF<sup>TM</sup> may be used in a sequential herbicide program for corn. Apply LEADOFF<sup>TM</sup> for burndown and residual weed control, followed by a post, in-crop application of DuPont<sup>TM</sup> REALM<sup>TM</sup> Q, DuPont<sup>TM</sup> RESOLVE® Q or DuPont<sup>TM</sup> STEADFAST® Q herbicides. Refer to the appropriate product label for use restrictions, application information, rotational crop guidelines, and cautionary statements prior to application.

#### **Additional Control of Grasses and Broadleaves**

LEADOFF<sup>TM</sup> may be tank mixed with full or reduced rates of labeled preplant/preemergence grass and broadleaf herbicides such as atrazine, DuPont<sup>TM</sup> CINCH® brands and DuPont<sup>TM</sup> BREAKFREE® brands to provide added residual activity or burndown activity on emerged weeds. Sequential applications of DuPont<sup>TM</sup> PREQUEL<sup>TM</sup>, CINCH® brands and BREAKFREE® brands may also be made following preplant applications of LEADOFF<sup>TM</sup>. Consult tank mix partner labeling for rate and soil-type restrictions.

#### Cotton/Soybeans - Preplant Only

Rate

Apply LEADOFF<sup>TM</sup> at 1.5 ounces per acre.

#### **Timing to Crop**

LEADOFF<sup>TM</sup> may be applied preplant after fall harvest through early spring 30 days or more prior to planting, whenever the ground is not frozen, to control emerged weeds and to provide limited residual control of early-emerging spring weeds.

#### **Burndown Tank Mixtures**

LEADOFF<sup>TM</sup> may be used as a preplant residual burndown treatment and may be tank mixed with other herbicides that are registered for preplant in cotton/soybean, including glyphosate, paraquat, glufosinate, 2,4-D LVE, and dicamba. Read and follow all instructions on this label and the labels of any tank mix partner before using in mixtures with LEADOFF<sup>TM</sup>. If the instructions on the tank mix partner label conflict with this LEADOFF<sup>TM</sup> label, do not use in a tank mixture with LEADOFF<sup>TM</sup>. Always follow directions of the most restrictive label.

#### **Sequential Application - Soybeans**

LEADOFF<sup>TM</sup> may be used in a sequential herbicide program in soybeans. Apply LEADOFF<sup>TM</sup> for burndown and residual weed control 30 days or more prior to planting, followed by an appropriate application of DuPont products such as DuPont<sup>TM</sup> CANOPY, DuPont<sup>TM</sup> ENVIVE®, DuPont<sup>TM</sup> ENLITE®, DuPont<sup>TM</sup> CLASSIC®, DuPont<sup>TM</sup> SYNCHRONY®, and/or DuPont<sup>TM</sup> ASSURE® II herbicides. Refer to the product labels for use restrictions, application information, rotational crop guidelines, and cautionary statements prior to application.

#### **Additional Control of Grasses and Broadleaves**

LEADOFF<sup>TM</sup> may be tank mixed with full or reduced rates of preplant herbicides registered for cotton and soybeans, such as DuPont<sup>TM</sup> CINCH®, and DuPont<sup>TM</sup> FIRSTSHOT® SG.

#### SPRAY ADJUVANTS

For control of emerged weeds, application of LEADOFF<sup>TM</sup> must contain an appropriate adjuvant. If applied in tank mix combination with a glyphosate or glufosinate herbicide that contains a built-in adjuvant system, no additional surfactant needs to be added. Consult local DuPont fact sheets, technical bulletins, and service policies prior to using other adjuvant systems. Products must contain only EPA-exempt ingredients.

#### Petroleum Crop Oil Concentrate (COC) or Modified Seed Oil (MSO)

- Apply at 1% v/v (1 gallon per 100 gallons spray solution) or 2% under arid conditions.
- MSO adjuvants may be used at 0.5% v/v (0.5 gallon per 100 gallons spray solution) if specifically noted on adjuvant product labeling.
- Oil adjuvants must contain at least 80% high quality, petroleum (mineral) or modified vegetable seed oil with at least 15% surfactant emulsifiers.

#### Nonionic Surfactant (NIS)

- Apply at 0.25% v/v (1 qt per 100 gal spray solution).
- Surfactant products must contain at least 60% nonionic surfactant with a hydrophilic/lipophilic balance (HLB) greater than 12.

#### **Ammonium Nitrogen Fertilizer**

# Mixing Instructions

#### **Fertilizer Carrier Instructions**

DuPont<sup>TM</sup> LEADOFF<sup>TM</sup> may be mixed with water or pre-dissolved in water and added to liquid fertilizer for preemergence application. When using liquid fertilizer as the carrier, always pre-slurry LEADOFF<sup>TM</sup> in water before adding fertilizer solutions. Add the LEADOFF<sup>TM</sup> slurry to the final complete liquid fertilizer mixture – do not add LEADOFF<sup>TM</sup> during the fertilizer mixing process.

Always use good agitation while adding the LEADOFF<sup>TM</sup> slurry to liquid fertilizers and maintain good agitation until sprayed. When using liquid fertilizer as the carrier, conduct a compatibility test with all components prior to mixing.

Do not use with spray additives or liquid fertilizer carriers that alter the pH of the spray solution below pH 5.0 or above pH 9.0 as rapid product degradation can occur. Spray solutions of pH 6.0 -8.0 allow for optimum stability of LEADOFF<sup>TM</sup>.

#### Water Carrier Instructions

- 1. Fill the tank 1/4 to 1/3 full of water.
- 2. While agitating, add the required amount of LEADOFF<sup>TM</sup>.
- 3. Continue agitation until the LEADOFF<sup>TM</sup> is fully dispersed, at least 5 minutes.
- 4. Once the LEADOFF<sup>™</sup> is fully dispersed, maintain agitation and continue filling tank with water. LEADOFF<sup>™</sup> should be thoroughly mixed with water before adding any other material.
- 5. As the tank is filling, add tank mix partners (if desired).
- 6. If the mixture is not continuously agitated, settling will occur. If settling occurs, thoroughly re-agitate before using.
- 7. Apply LEADOFF<sup>TM</sup> spray mixture within 48 hours of mixing to avoid product degradation.

If the selected companion herbicide has a ground or surface water advisory, consider this advisory when using the companion herbicide.

#### **Tank Mix Compatibility Testing**

Perform a jar test prior to tank mixing to ensure compatibility of LEADOFF<sup>TM</sup> and other pesticides. Use a clear quart jar with lid and mix the tank mix ingredients in their relative proportions. Invert the jar containing the mixture several times and observe the mixture for approximately 1/2 hour. If the mixture balls-ups, forms flakes, sludge, gel, oily film or layers, or other precipitates, it is not compatible and the tank mix combination should not be used.

#### **Ground Application**

Use a minimum of 15 gallons of water per acre (GPA) to ensure thorough coverage of the weeds and the best performance. Use a minimum of 10 GPA for light, scattered stands of weeds. For best performance, select nozzles and pressure that deliver MEDIUM spray droplets, as indicated, for example, by ASABE Standard S572.1. Nozzles that deliver COARSE spray droplets may be used to reduce drift, provided spray volume is increased to maintain coverage on small weeds.

For optimal product performance and minimal spray drift, adjust the spray boom to the lowest possible spray height recommended in manufacturers' specifications

#### **Aerial Application**

Use nozzle types and arrangements that will provide optimum spray distribution and maximum coverage at a minimum of 5 GPA.

Do not apply during a temperature inversion, when winds are gusty, or when conditions favor poor coverage and/or offtarget spray movement.

## RESTRICTIONS

- Do not plant cotton or soybeans fewer than 30 days following an application of DuPont<sup>TM</sup> LEADOFF<sup>TM</sup> herbicide.
- Do not apply the organophosphate insecticide "Counter" within 60 days of a preplant or preemerge application of LEADOFF<sup>TM</sup> since crop injury may result.
- Do not apply more than a total of 1.0 oz active ingredient rimsulfuron per acre per crop year to field corn from all sources. This includes combinations of preplant and preemergence applications of LEADOFF<sup>TM</sup> and DuPont<sup>TM</sup> PREQUEL®, as well as rimsulfuron from postemergence application(s) of products such as REALM<sup>TM</sup> Q, STEADFAST® Q or RESOLVE® Q.
- Do not apply preemergence on corn when planted to coarsetextured soils (sand, loamy sand or sandy loam) with less than 1% organic matter.
- Do not apply postemergence to any crop.
- Do not graze, feed forage, grain or fodder (stover) from treated areas to livestock within 30 days of LEADOFF™ application.

Injury or loss of desirable trees or vegetation may result from failure to observe the following:

- Do not apply LEADOFF<sup>TM</sup> or drain or flush application equipment on or near desirable trees or other plants, or on areas where their roots may extend, or in locations where the chemical may be washed or moved into contact with their roots.
- Do not use on lawns, walks, driveways, tennis courts, or similar areas.
- Do not contaminate any body of water.

#### PRECAUTIONS

- Allow at least 3 weeks between preemergence applications of LEADOFF<sup>TM</sup> and postemergence applications of rimsulfuron containing products, such as DuPont<sup>TM</sup> REALM<sup>TM</sup> Q, DuPont<sup>TM</sup> STEADFAST<sup>®</sup> Q, or DuPont<sup>TM</sup> RESOLVE<sup>®</sup> Q.
- LEADOFF<sup>™</sup> may interact with certain insecticides applied to soybean, cotton, or corn. Crop response varies with field crop, insecticide used, insecticide application method, and soil type.
- LEADOFF<sup>™</sup> may be applied to crops previously treated with "Fortress", "Aztec", or "Force" insecticides or other nonorganophosphate (OP) soil insecticides regardless of soil type.
- Preplant/Preemergence applications of LEADOFF<sup>TM</sup> to corn where an application of "Lorsban", or "Thimet" is planned may cause unacceptable crop injury, especially on soils of less than 4% organic matter.
- Crop injury may occur following an application of LEADOFF<sup>TM</sup> if there is a prolonged period of cold weather and/or in conjunction with wet soils.
- Prevent drift or spray to desirable plants.
- Thoroughly clean application equipment immediately after use. (See Sprayer Cleanup section of this label for instructions).

<sup>†</sup>The rotation interval must be extended to 18 months if drought conditions prevail after application and before the rotational crop is planted, unless sprinkler irrigation has been applied and totals greater than 15" during the growing season.

# SPRAYER PREPARATION/CLEANUP

The spray equipment must be cleaned before LEADOFF<sup>TM</sup> is sprayed. Follow the cleanup procedures specified on the labels of the previously applied products. If no directions are provided, follow the steps outlined in the "After spraying LEADOFF<sup>TM</sup>" section of this label (below).

It is recommended that during periods when multiple loads of LEADOFF<sup>TM</sup> herbicide are applied, at the end of each day of spraying, the interior of the tank be rinsed with fresh water and then partially filled, and the boom and hoses flushed. This will prevent the buildup of dried pesticide deposits, which can accumulate in the application equipment.

#### After spraying LEADOFF<sup>TM</sup> and before spraying crops other than cotton, field corn, or soybeans

To avoid subsequent injury to desirable crops, thoroughly clean all mixing and spray equipment immediately following applications of LEADOFF<sup>TM</sup> as follows:

1. Empty the tank and drain the sump completely.

2. Spray the tank walls with clean water using a minimum volume of 10% of the tank volume. Circulate the water through the lines, including all by-pass lines, for at least two minutes. Flush the boom well and empty the sprayer. Completely drain the sump.

- 3. Repeat step 2.
- 4. Remove the nozzles and screens and clean separately in a bucket containing water.

The rinsate solution may be applied back to the crop(s) listed on this label. Do not exceed the maximum labeled use rate. If cleaners are used, consult the cleaner label for rinsate disposal instructions. If no instructions are given, dispose of the rinsate on site or at an approved waste disposal facility.

Notes:

- 1. Always start with a clean spray tank.
- 2. A steam-cleaning aerial spray tank is recommended to facilitate the removal of any caked deposits.

#### SPRAY DRIFT MANAGEMENT

The interaction of many equipment and weather-related factors determines the potential for spray drift. The applicator is responsible for considering all these factors when making application decisions.

Avoiding spray drift is the responsibility of the applicator.

#### IMPORTANCE OF DROPLET SIZE

The most effective drift management strategy is to apply the largest droplets which are consistent with pest control objectives. The presence of sensitive species nearby, the environmental conditions, and pest pressure may affect how an applicator balances drift control and coverage. Applying larger droplets reduces drift potential, but will not prevent drift if applications are made improperly or under unfavorable environmental conditions.

A droplet size classification system describes the range of droplet sizes produced by spray nozzles. The American Society of Agricultural and Biological Engineers (ASABE) provide a Standard that describes droplet size spectrum categories defined by a number of reference nozzles (fine, coarse, etc.). Droplet spectra resulting from the use of a specific nozzle may also be described in terms of volume mean diameter (VMD). Coarser droplet size spectra have larger VMD's and lower drift potential

#### **CONTROLLING DROPLET SIZE - GROUND APPLICATION**

- Nozzle Type Select a nozzle type that is designed for the intended application. With most nozzle types, narrower spray angles produce larger droplets. The use of low-drift nozzles will reduce drift potential.
- Pressure The lowest spray pressures recommended for the nozzle produce the largest droplets. Higher pressure reduces droplet size and does not improve canopy penetration. When higher flow rates are needed, using a higher-capacity nozzle instead of increasing pressure results in the coarsest droplet spectrum.
- Flow Rate/Orifice Size Using the highest flow rate nozzles (largest orifice) that are consistent with pest control objectives reduces the potential for spray drift. Nozzles with higher rated flows produce coarser droplet spectra.

#### **CONTROLLING DROPLET SIZE – AIRCRAFT**

- Nozzle Type Solid stream, or other low drift nozzles produce the coarsest droplet spectra.
- Number of Nozzles Using the minimum number of nozzles with the highest flow rate that provide uniform coverage will produce a coarser droplet spectrum
- Nozzle Orientation Orienting nozzles in a manner that minimizes the effects of air shear will produce the coarsest droplet spectra. For some nozzles such as solid stream, pointing the nozzles straight back parallel to the airstream will produce a coarser droplet spectrum than other orientations.
- Pressure Selecting the pressure that produces the coarsest droplet spectrum for a particular nozzle and airspeed reduces spray drift potential. For some nozzle types such as solid streams, lower pressures can produce finer droplet spectra and increase drift potential

#### **BOOM LENGTH (AIRCRAFT), AND APPLICATION HEIGHT**

Boom Length (aircraft) - Using shorter booms decreases drift potential. Boom lengths are expressed as a percentage of an aircraft's wingspan or a helicopter's rotor blade diameter. Shorter boom length and proper positioning can minimize drift caused by wingtip or rotor vortices.

Application Height (aircraft) - Applications made at the lowest height that are consistent with pest control objectives and the safe operation of the aircraft will reduce the potential for spray drift.

Application Height (ground) - Applications made at the lowest height consistent with pest control objectives, and that allow the applicator to keep the boom level with the application site and minimize bounce, will reduce the exposure of spray droplets to evaporation and wind, and reduce spray drift potential.

#### WIND

Drift potential is lowest when applications are made in light to gentle sustained winds (2-10 mph), which are blowing in a constant direction. Many factors, including droplet size and equipment type also determine drift potential at any given wind speed. AVOID GUSTY OR WINDLESS CONDITIONS.

Local terrain can also influence wind patterns. Every applicator is expected to be familiar with local wind patterns and how they affect spray drift.

#### TEMPERATURE AND HUMIDITY

When making applications in hot and dry conditions, set up equipment to produce larger droplets to reduce effects of evaporation.

#### SURFACE TEMPERATURE INVERSIONS

Drift potential is high during a surface temperature inversion. Surface temperature inversions restrict vertical air mixing, which may cause small suspended droplets to remain close to the ground and move laterally in a concentrated cloud. Surface temperature inversions are characterized by increasing temperature with altitude and are common on nights with limited cloud cover and light to no wind. They begin to form as the sun sets and often continue into the morning. Mist or fog may indicate the presence of an inversion in humid areas.

Inversions may also be identified by producing smoke and observing its behavior. Smoke that remains close to the ground, or moves laterally in a concentrated cloud under low wind conditions indicates a surface inversion. Smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

#### SHIELDED SPRAYERS

Shielding the boom or individual nozzles can reduce the effects of wind. However, it is the responsibility of the applicator to verify that the shields are preventing drift and not interfering with uniform deposition of the product.

#### AIR-ASSISTED (AIR BLAST) FIELD CROP SPRAYERS

Air-assisted field crop sprayers carry droplets to the target via a downward-directed airstream. Some may reduce the potential for drift, but if a sprayer is unsuitable for the application and/or set up improperly, high drift potential can result. It is the responsibility of the applicator to determine that a sprayer is suitable for the intended application and is configured properly, and that drift is not occurring.

#### SENSITIVE AREAS

Making applications when there is a sustained wind moving away from adjacent sensitive areas (e.g., residential areas, bodies of water, known habitat for threatened or endangered species, non-target crops) is an effective way to minimize the effect of spray drift.

#### **DRIFT CONTROL ADDITIVIES**

Using product compatible drift control additives can reduce drift potential. When a drift control additive is used, read and carefully observe cautionary statements and all other information on the additive's label. If using an additive that increases viscosity, ensure that the nozzles and other application equipment will function properly with a viscous spray solution. Preferred drift control additives have been certified by the Chemical Producers and Distributors Association (CPDA).

#### INTEGRATED PEST MANAGEMENT

This product may be used as part of an Integrated Pest Management (IPM) program that can include biological, cultural, and genetic practices aimed at preventing economic pest damage. IPM principles and practices include field scouting or other detection methods, correct target pest identification, population monitoring, and treating when target pest populations reach locally determined action thresholds. #### RESISTANCE

DuPont<sup>™</sup> LEADOFF<sup>™</sup>, which contains the active ingredients rimsulfuron and thifensulfuron -methyl, is a Group 2 herbicide based on the mode of action classification system of the Weed Science Society of America.

When herbicides with mode of action classifications that affect the same biological sites of action are used repeatedly over several years to control the same weed species in the same treatment area, naturally-occurring resistant biotypes may survive a correctly applied herbicide treatment, propagate, and become dominant in that area. Adequate control of these resistant weed biotypes cannot be expected.
