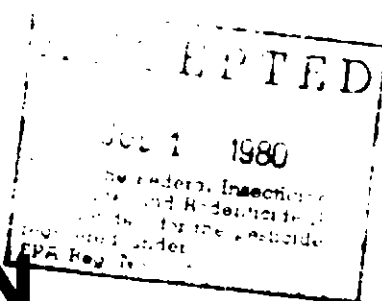

ACTIVE INGREDIENTS:

Diethanolamine salt of 2,4-dichlorophenoxy-acetic acid* 24.01%

Diethanolamine salt of 2-(2-methyl-4-chlorophenoxy)propionic acid** 24.91%

INERT INGREDIENTS 51.04%

*Equivalent to 16.27% of the 2,4 isomer of 2,4-D or 1.58 lb. 2,4-D acid per gallon

**Equivalent to 16.72% of MCPP acid or 1.62 lb. MCPP acid per gallon

STATEMENT OF PRACTICAL TREATMENT

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS
